# Global Urban Competitiveness Project



We are a group of scholars and researchers who study a variety of important issues that confront residents of urban areas and the policy leaders who seek to enhance the vitality and competitiveness of the world's cities, towns and urban regions. We represent urban areas that are situated in: Australia, China, Canada, India, Italy, Kenya, Korea, Mexico, the Netherlands, Portugal, Spain, and The United States, and hence we offer a truly global perspective on these policy issues.



# An Introduction to the Global Urban Competitiveness Project (GUCP)

The objective of the GUCP was to be an on-going research project dedicated to **the scholarly study of urban competitiveness** and to the ways in which this knowledge can be of assistance to urban, national and international leaders in planning strategically the economic futures of their cities. Urban competitiveness refers to the degree to which a city, or urban region, in comparison with other "competing" cities, is able to provide the jobs, income, cultural and recreational amenities, degree of social cohesion, governance and urban environment to which its current and targeted new residents aspire. Decision-makers in urban economies throughout the world are being forced to confront the issues that continue to intrigue academic researchers for decades: 1) the relevance for urban economies of theoretical concepts such as economies of agglomeration, the activity clustering, the economics of the Marshallian industrial district, regional innovation systems, and so forth, 2) the consequences for urban economies of the powerful policy choice by national governments of trade and financial market liberalization, 3) the impacts on urban economic structures and specialization of rapid changes in technology, 4) issues of effective governance, 5) social and spatial aspects of urban economies, and 6) the participation of cities in inter-urban globally-linked networks. We in GUCP treat these issues in our annual research workshop, and make our findings known through publication of the proceedings.


#### The Activity of The GUCP

Fifteen GUCP meetings have been held in: China (five), Mexico (three), the US, Korea and Italy (two each) and the Netherlands (one). Most of these conferences have generated published books: seven were edited by Prof. Kresl (with Edward Elgar Publishers, UK), three by Ni (also by Elgar), two by Prof. Sobrino (with El Colegio de Mexico), one by Prof. van den Berg, and one by Prof. Orihuela (with Instituto Mora, Mexico). Individual members are, of course, very active in publishing their research.

#### The Future of GUCP

In furtherance of our objective of being of benefit to city and regional decision makers, our 2022 conference in Venice was devoted to *The Impact of COVID on Cities and Regions: Policy Responses of Local Leaders*, and published by Edward Elgar in October, 2023. In this project we examined the short-term impacts of COVID and the immediate responses of city and regional leaders. In our research workshop in Leipzig this September, "The Transformed Central City: Surviving or Thriving after COVID", we will examine what these leaders must do in the longer term to counter the lasting negative impacts of COVID on cities, and especially on their downtown centers, to revitalize the economic competitiveness and residential attractiveness of their city. This revitalization must be extended to all types of business entities and to all social groups. Given the deleterious impacts of distance working, technological changes in general, the lack of affordable housing, the deterioration of many city centers, and challenges to the vitality of a city's hospitality, cultural and entertainment sectors the vitality, competitiveness and attractiveness of many cities and regions have been

put at risk. City leaders must enhance the capacity of their cities to be centers of innovation and creative thinking. The challenges to city leaders are daunting.

# Mission Statement of the Global Urban Competitiveness Project

In the present environment, trade liberalization at the regional and global level and advances in the technologies of production, transportation and communication are taking place concomitantly with national governments reviewing their capacity to intervene in their own national economies. As a consequence, increasing responsibility is being placed on public and private sector leaders of urban economies with regard to planning for the economic viability of their cities. Thirty years ago the Manifesto of Eurocities proclaimed that "now is the time of the cities." To those who are participating in the Global Urban Competitiveness Project (GUCP) it is clear that this proclamation is valid today for cities on all continents, and for all cities whatever their stage of development, place in the global urban hierarchy, or economic function or role.

The GUCP is an on-going research project

dedicated to the scholarly study of urban competitiveness and to the ways in which this knowledge can be of assistance to urban, national and international leaders in

planning strategically the economic futures of their cities. Urban competitiveness refers to the degree to which a city, or urban region, in comparison with other "competing" cities, is able to provide the jobs, income, cultural and recreational amenities, degree of social cohesion, governance and urban environment to which its current and targeted new residents aspire. Decision-makers in urban economies throughout the world are being forced to confront the issues that continue to intrigue academic researchers for decades: 1) the relevance for urban economies of theoretical concepts such as economies of agglomeration, the activity clustering, the economics of the Marshallian industrial district,

regional innovation systems, and so forth, 2) the consequences for urban economies of the powerful policy choice by national governments of trade and financial market liberalization, 3) the impacts on urban

economic structures and specialization of rapid changes in technology, 4) issues of effective governance, 5) social and spatial aspects of urban economies, 5) the participation of cities in inter-urban globally-linked networks, and 6) the essential vitality of innovation and creative thinking.

The benefits to be derived from the establishment and operations of the GUCP are: 1) better communication among those who are doing research on urban competitiveness, 2) enhanced contact between researchers and practitioners in urban governance and leadership positions, 3) more effective economic strategic planning in cities throughout the world, 4) to make municipal leaders more able to enhance the competitiveness of their metropolitan regions and thereby to improve the economic futures of the residents of these regions, and 5) to increase the interest in and research in urban competitiveness on the part of researchers in both industrialized and developing economies.

### **GUCP Members**

#### **Peter Karl Kresl**

Peter Karl Kresl is the President of GUCP, and Charles P. Vaughn Professor of Economics (emeritus) at Bucknell University. His principal interests as an economist are now related to rational policy for urban economies in our rapidly changing international context. He has worked on projects for the OECD, UN-Habitat II, the Fulbright Program, UN World Cities Day conference, as well as entities in Turin, Italy, the Basque Institute, and the Beijing World City Conference. He has been visiting professor at McGill University (Montreal) and Carleton University (Ottawa), the Norwegian School of Economics (Bergen), Lund University in Sweden, and St. Lawrence University. He has been President of the Association for Canadian Studies in the US and Executive Director of the International Council for Canadian Studies (Ottawa). His most recent research has been on the impacts of COVID on cities and regions and the policy responses to these impacts. His most recent publications include *The City and the Quality of Life* (Awarded the 2033 Best Book by the Reginal Studies Association), *Public Policy in Contentious Times, The Aging Population*, and *The Competitiveness of Cities*.

#### Ni Pengfei

Dr. Ni is General Secretary of GUCP, Director of IFTE CASS (Chinese Academy of Social Sciences), Economics PhD, researcher, PhD Tutor. Main research fields include urban economy, urban competitiveness, real estate finance, etc. Ni is the chief editor of the *Anniversary Report of Chinese Urban Competitiveness*, *Global Urban Competitiveness*, *Chinese Business Environment Report* (in cooperation with The World Bank). He won the 11<sup>th</sup> "Sun Yefang Prize in Economic". His research in urban competitiveness has raised wide concern from scholars, politicians, entrepreneurs and the public.

#### **Edward Blakely**

Professor Edward James Blakely is an internationally renowned scholar, researcher, educator, public leader and practitioner in the fields of urban planning and policy, transportation, housing and disaster management. With over hundred publications in these fields his major contributions include the pathfinding books Planning Local Economic Development: Theory and Practice (Sage), where he pioneered the field of local economic development planning, and Separate Societies: Poverty and Inequality in U.S. Cities (Temple University Press), in which he examined the social and economic conditions in American cities and the ways in which they contribute to the segregation and isolation of poor and minority communities. His work in these fields has been influential at the highest levels of state and federal governments in the United States and many other countries, including Australia, Korea, Japan, Sweden, Indonesia, New Zealand and Vietnam, as well as the OECD. Professor Blakely is emeritus professor of urban planning at the University of California Berkeley and has held Deanships in Planning and Public Policy at the University of Southern California, Los Angeles and of the Milano Graduate School of Public Policy, New School University, New York. He is also currently Chair of a key Advisory Board of the University of California Systemwide and holds a permanent Visiting Professorship in Urban Climate Change at the University of Venice (Department of Architecture and Arts Università IUAV di Venezia). His current passion is the challenge of how to make cities vibrant spaces for innovation.

#### **Luis Carvalho**

Luís Carvalho (PhD, Erasmus University Rotterdam) is Associate Professor at the School of Economics and Management at the University of Porto (FEP-UP). He is currently scientific director of the MSc in Innovation Economics and Management, and Associate Editor of the journal Environmental Innovation and Societal Transitions, published by Elsevier. His work primarily addresses the socio-spatial dynamics of knowledge and innovation, urban planning, and local economic policy issues. His research has been published in journals such as Regional Studies, Research Policy, Environment and Planning A, Cambridge Journal of Regions, Economy and Society, European Planning Studies, among others. Recent research focuses on the planning of innovation districts, smart city development and transformative innovation in cities and regions.

#### **Dong-Sung Cho**

Received his Doctor of Business Administration degree at Harvard Business School. He was Professor of Strategy at two institutions: Seoul National University Business School in Seoul for 36 years and Cheung Kong Graduate School of Business in Beijing for 2 years. Since July 2016, he is serving Incheon National University, Incheon as its 15<sup>th</sup> President. His main research fields are competitiveness of nations and cities, nation brand, globalization strategy, management design and mechanism-Based View. He has published 6 books in English, 5 books in Chinese and 65 books in Korean. President of Korea awarded him "Order of Service Merit-Yellow Stripes." President of Finland awarded him "The Knight, First Class of the Order of the White Rose of Finland." He was conferred Honorary Doctor of Philosophy by Aalto University Helsinki.

#### Vittorio Galletto

Vittorio Galletto is Head of the Regional and Urban Economics Department of the Institute of Regional and Metropolitan Studies of Barcelona (IERMB) and associate professor at the Autonomous University of Barcelona. PhD in Economics. Researcher in the IERMB Economics Department since 2009, first as project manager and then as head of department since 2010. He previously worked in the Department of Applied Economics at the UAB as an associate professor and researcher. He has also worked with private sector consultancy firms, specializing in local development projects. His current research at the IERMB focuses on inclusive urban growth, productivity and innovation.

#### Daniele letri

Daniele letri is full professor of Geograhy a the Free University of Bolzano-Bozen. His research is mainly focused on the study of urban and regional competitiveness and the elaboration of local development policies, with a focus of inner/internal and peripheral areas.

#### Shen Jianfa

He recently participated in the annual conference of UNIDO 2023 in Vienna, Austria. He has been a research consultant at the International Labor Organization (ILO), the United Nations Conference on Trade and Development (UNCTAD), the Inter-American Development Bank (IDB), the Economic Commission for Latin America and the Caribbean (ECLAC), as well the World Bank. He has carried out various studies and evaluations for the Mexican Government, through agencies and entities) such as the Ministry of Labor and Social Welfare, the Ministry of Social Development, the Ministry of Economy, the Ministry of Public Education, the National Savings Bank and Services Financiers and DICONSA, among others.

In 2005 professor van den Berg was one of the founders of the Economic Development Board Rotterdam (EDBR). Between 2011 and 2014 professor van den Berg was affiliated to the Ca' Foscari university of Venice. #### Cities as Innovation Spaces
